

## **GENERAL TERMS AND CONDITIONS OF SALE**

The present conditions govern the sales of the works, exclusively on the [www.after7seas.com](http://www.after7seas.com) website. They are accessible on this site by the buyer at the time of ordering.

### **§ 1. PRICES AND CANVASES**

The prices appearing on this site are indicated in € - all taxes included - excluding delivery charges (see delivery). The ordered artworks are invoiced at the moment the order is placed. For an order outside metropolitan France: you are the importer of the concerned painting. The paintings remain the full property of after7seas until full payment of the indicated price has been received.

### **§ 2. ORDERING AND VALIDATION OF THE TRANSACTION**

When you confirm your order by clicking on the "validate" button, you declare that you have read and accepted these general terms and conditions of sale in their entirety. As soon as your order has been registered, an acknowledgement of receipt will be sent to you by e-mail after validation of payment.

We reserve the right to cancel any order from a customer with whom there is a dispute over payment of a previous order.

The contract is concluded upon confirmation of payment by the bank.

### **§ 3. PAYMENT**

The payment of your purchases is made in €. Following payment methods are possible:

- By credit card (Visa, Mastercard, Amex): your payment is accepted online at the time of your order. Your bank details are encrypted during the transaction.

Orders placed are shipped with the COLISSIMO service the next day after payment is received.
